Restriction to one of the following inventions is required under 35 U.S.C. 121:

- Claims 1-11, drawn to a fluid processing set, classified in class 210, subclass 257.1.
- II. Claims 12-23, drawn to a method for purifying a biological fluid, classified in class 210, subclass 668.

The inventions are distinct, each from the other because:

Inventions I and II are related as process and apparatus for its practice. The inventions are distinct if it can be shown that either: (1) the process as claimed can be practiced by another materially different apparatus or by hand, or (2) the apparatus as claimed can be used to practice another and materially different process. (MPEP § 806.05(e)). In this case the apparatus of Group I could be used to carry out another process, different from that of Group II. For example, this processing set could be used to purify fluids other than biological fluids (e.g. waste water). Also, this processing set of Group I could be used in the absence of a photochemical agent, which agent is required by the process of Group II (see claim 12, line 22).

Because these inventions are distinct for the reasons given above and have acquired a separate status in the art as shown by

their different classification and divergent subject matter, and because the searches for the individual Groups are not coextensive, restriction for examination purposes as indicated is proper.
