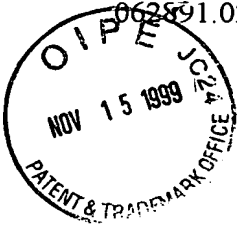

SECOND REQUEST FOR CORRECTED OFFICIAL FILING RECEIPT



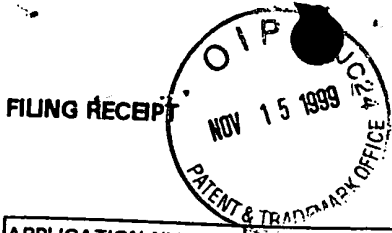

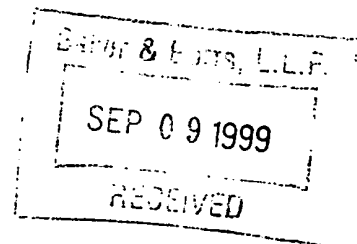
