Continuation of 5. does NOT place the application in condition for allowance because: Applicant asserts that the Rossman reference does not disclose "a small footprint device communicating with a service accessible from the first network to send information to the service accessible from the first network and "the service accessible from the first network storing the information and generating the content based on the information"

Examiner respectfully disagrees. Rossman clearly discloses a small footprint (100 or 101 fig.1) to provide resource in two-way data communications chosen by the server to a first network (110 fig.1) (see figs.1, 2A, abstract, col.8 line 56 to col.9 line 60) and further users to access information from the network (110 fig.1) (see col.10 line 14 to col.11 line 64) .
