1. This is in response to the Decision from the Board of Appeals and Applicant's amendment filed on 3/31/2005. Claims 5-38 are presented for examination.

Allowable Subject Matter

2. Claims 5-38 are allowed.

Reason for allowance

3. This communication warrants no examiner's reason for allowance, as applicant's reply makes evident the reason for allowance, satisfying the record as whole as required by rule 37 CFR 1.104(e). In this case, the substance of the Decision from the Board of Appeals on 1/31/2005 with respect to the claim limitations point out the reason claims are patentable over the prior art of record.
