## DETAILED ACTION

### *Allowable Subject Matter*

1. Claims 13-17, 20-25, 27 and 39 allowed.

The following is an examiner's statement of reasons for allowance:

In regards to claims 13-17 and 20-24, the prior art of record fails to teach or rendered obvious "in the event there is said video object to be displayed at said time count in said multimedia program, obtaining said at least one level of quality supplement data portions for a first frame to be displayed in the next play operation for displaying a quality-enhanced version of said first frame to be displayed".

In regards to claims 25, 27 and 39, the prior art of record fails to teach or rendered obvious "reading the levels of quality supplement data of a last displayed frame while synchronously rotating the tape recording media, and sending the levels of quality supplement data to the client terminal one by one to add each level of quality supplement data to the base portion of the last displayed frame".

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."

In regards to claims 13-17 and 20-24, Ramasubramanian only teaches issuing a play control command and receiving supplement data portions in response thereto, where Chaddha teaches the improvement of specifically enhancing the basic portion and supplement portion by adding the two portions together. Ramasubramanian and

Chaddha both fail to disclose a time count in the multimedia program, as well as determining whether there is a video object in the multimedia program after a play control command is issued during a stop period.

In regards to claims 25, 27 and 39, Ramasubramanian only discloses that the basic and supplement data portions are stored on a storage device and is silent to either a disk storage system or a tape storage system (see Figure 1A-1B). Chaddha discloses offloading lower resolution versions of the video to tape, but keeps the higher resolutions of the video on the disk subsystem 90, therefore only the basic portions are stored on a tape recording medium. Therefore, Ramasubramanian and Chaddha both fail to disclose storing the basic portions on a tape recording medium and the quality supplement portions on a different tape recording medium.
