DETAILED ACTION

Allowable Subject Matter

Claims 1-23 are allowed.

The following is an examiner's statement of reasons for allowance: MPEP § 1214.04 states that a "complete reversal of the examiner's rejection brings the case up for immediate action by the examiner" and that the "examiner should never regard such a reversal as a challenge to make a new search to uncover other or better references." Squilla (USPN 5,898,779) does not teach digitally *encoding* the authentication token for rendering at a printer a signed and authenticated hardcopy document [see page 10, lines 4-10 of BPAI Decision dated 10 March 2008]. Further, a perusal of the prior art searches performed do not reveal any additional prior art references that would anticipate the claims and/or render the claims obvious to one of ordinary skill in the art at the time of the invention. Accordingly, claims 1-23 are allowed.
