1. (Once Amended) A method for controlling scanning devices using control sheets, comprising the method comprising:

 - processing control instructions from said control image; and
 - creating output in accordance with said control instructions.
2. (Once Amended) The method as claimed in claim 1 wherein said imaging job is an image acquisition task.
