EXAMINER'S AMENDMENT

The application has been amended as follows:

In claim 66, step A), line 2, after 'wherein', 'the antibody or scFv/Fab antibody fragment' has been replaced by "members of the antibody library or members of scFv/Fab antibody fragment library".

In claim 87, line 1, after 'step ©', 'of claim 1' has been deleted.

2. The following is an examiner's statement of reasons for allowance: The claimed method of acquiring monoclonal antibody or scFv/Fab antibody fragment against a target structure present in the tissue sections is neither taught nor suggested by the prior art .
