#### **REMARKS**

Claims 71-72 were rejected under 35 U.S.C. § 102(e) as being anticipated by Boyer (U.S. Patent No. 6,268,849). This rejection is obviated by the cancellation of claims 71-72.

# 35 U.S.C. § 103(a) Legall / Alten Rejection



This rejection is obviated by the cancellation of claims 1-2, 6-8, 11-23, 26-30, 34-37, 41, 44, 56, 59-61, and 64-67.

Claims 24-25, 31-33, and 57-58 were rejected under 35 U.S.C. § 103(a) as being unpatentable over Legall (U.S. Patent No. 6,005,565) in view of Alten (U.S. Patent No. 5,635,978) and further in view of Ballard (U.S. Patent No. 6,182,050). This rejection is obviated by the cancellation of claims 24-25, 31-33, and 57-58.

# 35 U.S.C. § 103(a) Ballard / Legall / Alten Rejection

Claims 63 and 69 were rejected under 35 U.S.C. § 103(a) as being unpatentable over Ballard (U.S. Patent No. 6,182,050) in view of Legall (U.S. Patent No. 6,005,565) and further in view of Alten (U.S. Patent No. 5,635,978). This rejection is obviated by the cancellation of claims 63 and 69.
