Also, the brief omits the statement required by 37 CFR 1.192(c)(7) that one or more claims do not stand or fall together, note page four section seven of the Appeal Brief. Applicant states a separate basis for patentability exists for each group of claims and gives arguments in support in section eight; but fails to incude the required statement.
