3. The following is an examiner's statement of reasons for allowance:

The decision by the Board of Patent Appeals and Interferences mailed September 30, 2004 finds Applicant's arguments regarding claims 3, 4, 9 and 10 convincing. The prior art of record fails to teach the limitation wherein the transformation step further comprises the step of reordering the data into column major order as cited in independent claims 3 and 9.
