## KNOW ALL MEN BY THESE PRESENTS, THAT

WHEREAS, I, Charles R. CANTOR, a citizen of the United States of America, residing at 11 Bay State Road #6, Boston, MA 02215, (hereinafter "ASSIGNOR") have invented certain new and useful improvements in SOLID PHASE SEQUENCING OF NUCLEIC ACIDS described in the application for United States Letters Patent filed on April 11, 1995, and assigned Application Serial No. 08/420,009.
