The Examiner's comments regarding the drawings are acknowledged. Replacement drawings will be filed in due course.

The Examiner's observation that the present application does not contain an abstract is respectfully submitted to be erroneous. The present application is a national stage filing of the corresponding PCT application. In accordance with PCT national stage applications, the abstract appears on the front page of the application rather than on a separate sheet immediately following the specification. Nonetheless, to expedite prosecution and for the Examiner's convenience, an abstract is enclosed herewith on a separate sheet.

The rejection of claims 45, 46, and 48-52 under 35 U.S.C. 102(e) as allegedly being anticipated by Desai, et. al. (U.S. Patent No. 5,916,596), is respectfully traversed. Applicants respectfully submit that the '596 patent is not a patent "by another". Specifically, Desai, Soon-Shiong, and Magdassi are named as inventors both on the '596 patent and on the present application. Thus, it is respectfully submitted that the rejection under 102(e) is not properly applied. Accordingly, reconsideration and withdrawal of the rejection of claims 45, 46, and 48-52 under 35 U.S.C. 102(e) are respectfully requested. Wmm

The rejection of claims 1-44 and 47 under 35 U.S.C. 103(a) as allegedly being unpatentable over Desai, et. al. in view of Langer, et. al. (*Seminars in Oncology*, 1997, 24, 4 Wmm Suppl. 12, p 81-88), is respectfully traversed. Applicants respectfully submit that Desai (the '596 patent) is not a patent by another and is therefore not properly cited as prior art.


Moreover, Applicants respectfully submit that Langer is also not properly cited as prior art. The present application claims priority to U.S. Serial No. 60/051,021, filed June 27, 1997, and therefore antedates Langer, whose publication date is August, 1997. Accordingly, reconsideration and withdrawal of the rejection of claims 1-44 and 47 under 35 U.S.C. 103(a) are respectfully requested.
