

AMENDMENTS TO THE DRAWINGS

Replacement sheets of drawings Figures 1-4 are provided. Please replace Figures 1-4 of the application with the attached replacement sheets containing Figures 1-4.

The attached replacement sheets reflect the figures as originally filed on June 26, 1998 as part of International Application No. PCT/US98/13272, the international application for which the present application is a national stage application, rather than the Figures 1-4 that were later submitted as replacement sheets on September 25, 1998, in the international application in response to the Invitation to Correct Defects mailed July 27, 1998. REMARKS

As noted above, the substitute specification corresponds to the specification as originally filed in the international application on June 26, 1998, and contains no new matter.
