


In response to the Final Office Action mailed June 6, 2002, please consider the following timely-filed Amendment and Remarks.

AMENDMENT

In the Specification

Page 10, paragraph beginning at line 22, amend the paragraph to read as follows:

--Additional materials may be included to enhance lamp performance. For example, a semi-transparent layer may also be applied to at least some portion of the interior of the enclosure in Fig. 2 (e.g., at layer 228 or along inner surface of 214) to prevent ultraviolet
