

DETAILED ACTION

ALLOWANCE

2. The following is an Examiner's Statement of Reasons for Allowance:

The prior art taken alone or in combination failed to teach or suggest in response to receipt of information from the cash deposit payment processor that the required deposit amount has been received at a deposit location registered with the cash deposit payment instrument processor, updating the data field in the registration record indicating that the required deposit amount has been received by the cash deposit payment instrument processor as recited in independent claims 63, 81, 99, 116, 133 and 151.
