Advisory Action

Response to Arguments

Applicant's arguments filed February 28, 2006 have been fully considered but they are not persuasive.

Applicant argues "None of the references Edmonds, Imanaka, and Sawicz mention head-end controllers and the combination would not result in a number of head-end controllers coupled to each server module via at least two signal paths, wherein each communication between a head-end controller and a server module is coincidentally sent through the two signal paths as claimed." Edmonds shows a plurality of head-end controllers coupled to each server module of the plurality of server modules via at least two signal paths (fig. 5 items 216 and 220, director, col. 7 lines 25-55, director for providing load balancing algorithms).

In response to applicant's argument that the examiner's conclusion of obviousness is based upon improper hindsight reasoning, it must be recognized that any judgment on obviousness is in a sense necessarily a reconstruction based upon hindsight reasoning. But so long as it takes into account only knowledge which was within the level of ordinary skill at the time the claimed invention was made, and does not include knowledge gleaned only from the applicant's disclosure, such a reconstruction is proper. See *In re McLaughlin*, 443 F.2d 1392, 170 USPQ 209 (CCPA 1971).

In response to applicant's argument that there is no suggestion to combine the references, the examiner recognizes that obviousness can only be established by

combining or modifying the teachings of the prior art to produce the claimed invention where there is some teaching, suggestion, or motivation to do so found either in the references themselves or in the knowledge generally available to one of ordinary skill in the art. See *In re Fine*, 837 F.2d 1071, 5 USPQ2d 1596 (Fed. Cir. 1988) and *In re Jones*, 958 F.2d 347, 21 USPQ2d 1941 (Fed. Cir. 1992).

Edmonds discloses an apparatus having provider equipment for improving fault tolerance in an Ethernet environment (Col 2, lines 5-13, 15-16, 59-62). Imanaka discloses a redundancy scheme for Ethernet communications, thereby providing robust communication between two systems (Abstract, Col 2, Lines 14-34; Col 4, Lines 1-28). Sawics discloses a multi-stage video switch in a redundant system. Edmonds, Imanaka and Sawics are clearly analogous art.


In response to applicant's argument that the references fail to show certain features of applicant's invention, it is noted that the features upon which applicant relies (i.e., "controlling video sessions" or "separate head-end controllers") are not specifically recited in the rejected claim(s). Although the claims are interpreted in light of the specification, limitations from the specification are not read into the claims. See *In re Van Geuns*, 988 F.2d 1181, 26 USPQ2d 1057 (Fed. Cir. 1993).
