Allowable Subject Matter

1. Claims 10-14, 17-23, 26, 27, 68-71 and 76-93 allowed.
2. The following is an examiner's statement of reasons for allowance: Regarding independent claims 10 and 19 and the dependent claims depend from them, Prior art failed to establish a semiconductor device having a pixel TFT and a driver TFT with overlapping lightly doped regions, where gate electrode of pixel and driver TFT comprise a first conductive layer, where the gate electrodes of the pixel and driver TFT are in electrical contact with gate wirings where the gate wirings comprising a second conductive layer in areas outside of channel forming regions of pixel and driver TFT. Regarding Claims 68, 76 and 80 and the dependent claims that depend from them, prior art failed to establish a semiconductor layer with lightly doped and channel forming regions, gate electrode comprising first conductive layer, gate insulating film, gate wiring comprising second conductive layer and a storage capacitor comprising a portion of semiconductor layer, a portion of gate insulating film, a third conductive layer comprising the same material as first conductive layer and a fourth conductive layer comprising the same material as second conductive layer


