



<u>REMARKS</u>

Claims 1-5, 7-9, 14, 16-18, 20, 21 23, 24, 26, and 27 have been rejected under 35 USC §103(a) as being unpatentable over DasGupta et al and Dijkstra, in combination. Claim 28 has neither been rejected or indicated as allowable, so it treated below as one of the rejected claims. The rejection states that:

DasGupta teaches a method of applying betulinic acid to skin for the treatment of melanoma....DasGupta does not teach the method comprising Vitamin D analogs. However, Dijkstra teaches a method of applying vitamin D analogs to skin for the treatment of melanoma....In the absence of unexpected results, it would have been obvious to one having otd/26/2002 HDENNY Otdinary skillein the artist combine the methods. The activity of the this combination allows compositions containing them to be used in a variety of skin treatment methods, for example, in treating dry skin, protecting the skin from the effects of irritants and UV exposure, and enhancing the process of sunless tanning.
