Please find below and/or attached an Office communication concerning this application or proceeding.

1. The reply filed on June 6, 2003 is not fully responsive to the prior Office Action because of the following omission(s) or matter(s): some of the claims identified as reading on the elected species do not appear to read on those species. In particular, claim 75 as written appears to require a molecule comprising a non-elected sequence, SEQ ID NO: 4. Claim 78 requires SEQ ID Nos 16 and 17, which are not indicated as being an elected primer pair. Accordingly, clarification is required. Specifically, Applicant is requested to clarify the election (i.e., was it Applicant's intent to elect SEQ ID NO: 16 and 17?), to amend the claims appropriately or to otherwise clarify how the recited claims read on the elected primer pairs. See 37 CFR 1.111.

2.
