DETAILED ACTION

1. Claims 1, 4-6, 21-26, and 29-33 is allowed.

Claims 2-3, 17-20, and 27-28 have been cancelled.

2. An appeal conference was held on 11/02/2006 in response to an Appeal Brief (6/30/2006), where conferees found the arguments persuasive and the claims have overcome the art rejection. Therefore, the claimed invention is in condition for allowance.

Allowable Subject Matter

3. **The following is an examiner's statement of reasons for allowance:**

Claims 1, 4-6, 21-26, and 29-33 is allowable over art. Claims 1, 11, and 12 have overcome the Iverson invention and other prior arts because they fail to teach a data communications system for distributing digitally encoded data comprising distributing the multiplicity of encrypted frames with control field to a multiplicity of users where a seed value for key generation to respective secure modules located at each of the multiplicity of users are communicated and decrypting the data frames at respective users using keys derived from the seed value communicated to the secure module such that the secure module being arranged to enable decryption of a respective frame only when said control field has been passed to the secure module. In addition, prior art fails to pass a control message for modifying and controlling the availability of keys in the control field to the secure module at a selected one or more users

whereby at the secure module of the or each selected user, in response to the said control message, controlling the availability of keys generated from the seed value, thereby controlling access by the users to the said data.


All dependent claims are allowed due to dependency.


