Claim 204 (currently amended): A method of acquiring information from individuals who want to volunteerwolunteering for ongoing consideration as potential candidates for participating as research subjects in any of a plurality of clinical trials registered with a recruitment service provider identified as currently recruiting research subjects, by means of a server operated by [[a]] the recruitment service provider, the server being configured to communicate with a plurality of end-user computer terminals via a network, the method comprising the steps of:

the server transmitting for display on one end-user terminal a health survey form accessible to one of the individuals, the health survey form soliciting from the individual contact information by which the <u>one</u> individual may be contacted, and at least one of the individual's personal and medical information <u>from which the individual may be evaluated as a potential candidate for any of the plurality of registered clinical trials</u>, whereby the individual agrees to volunteer to be considered on an ongoing basis for selection as a potential candidate for participating as a research subject in any of the plurality of <u>registered</u> clinical trials;

the server receiving information transmitted by the individual via the one end-user computer terminal, the information containing the individual's contact information and the at least one of the individual's personal and medical information; and

the server storing the at least one of the individual's contact information and the at least one of the individual's personal and medical information in a database, thereby registering the individual for ongoing consideration as a potential candidate for participating as a research subject in any of the plurality of <u>registered</u> clinical trials that is identified by the recruitment service provider as [[currently]] recruiting candidates,

wherein the <u>plurality of registered clinical trials includes clinical trials that were first</u>

<u>registered and remain registered with the recruitment service provider as of the time individual's</u>

ongoing consideration comprises consideration for any of the plurality of clinical trials registered with the recruitment service provider at or after the time when the individual is first registered by the server, and clinical trials that are first registered with the recruitment service provider after the time when the individual is first registered and while the individual remains registered with the server.

Claim 205 (currently amended): The method of claim 204, wherein the individual's agreement the information received by the server signifies an agreement by the individual to release the contact information to a [[the]] representative of any the at least one matching clinical trial for which the individual is evaluated to be a potential candidate.

Claim 206 (currently amended): The method of claim 204, wherein the health survey form solicits [[the]] identification of one or more medical conditions of the individual for which the individual wishes to be considered as a potential candidate for participating as a research subject in one or more of the plurality of clinical trials.

Claim 207 (currently amended): The method of claim 204, wherein the health survey form solicits the identification of one or more clinical researchers for whom the individual wishes to be considered as a potential candidate for participating as a research subject in any of the plurality of registered clinical trials that are associated with the one or more clinical researchers.

Claim 208 (previously presented): The method of claim 204, wherein the network comprises one or more of the Internet, the World Wide Web, an intranet, a local area network, a wide area network and a wireless communications network.

Claim 209 (currently amended): The method of claim 204, further comprising the step of:

the server transmitting registration information for display on a second end-user computer terminal, said registration information soliciting information for registering a clinical researcher administering one or more of the plurality of clinical trials to be registered.

Claim 210 (currently amended): A method by which an individual may register as a volunteer to be considered on an ongoing basis for selection as a potential candidate for participating as a research subject in any of a plurality of clinical trials that are registered with a recruitment service provider, and by which the individual may subsequently opt out of the registration, by means of a server operated by [[a]] the recruitment service provider, the server being configured to communicate with a plurality of end-user computer terminals via a network, the method comprising the steps of:

the server transmitting for display on the one end-user terminal a health survey form soliciting from the individual contact information by which the individual may be contacted, and at least one of the individual's personal and medical information from which the individual may be evaluated as a potential candidate for any of the plurality of registered clinical trials, whereby the individual agrees to volunteer to be considered on an ongoing basis for selection as a potential candidate for participating as a research subject in any of the plurality of registered clinical trials;

the server receiving first information transmitted by the individual via the one end-user computer terminal, the <u>first</u> information <u>including</u> [[containing]] the individual's contact information, personally-identifying information of the individual and the at least one of the individual's personal and medical information; [[and]]

the server storing the individual's contact information, the personally-identifying information of the individual and the at least one of the individual's personal and medical information in a database, thereby registering the individual for ongoing consideration as a potential candidate for participating as a research subject in any of the plurality of clinical trials that is identified by the recruitment service provider as [[currently]] recruiting candidates,

wherein the <u>plurality of registered clinical trials includes clinical trials that were first</u>

<u>registered and remain registered with the recruitment service provider as of the time individual's ongoing consideration comprises consideration for any of the clinical trials registered with the</u>

recruitment service provider at or after the time when the individual is first registered by the server, and clinical trials that are first registered with the recruitment service provider after the time when the individual is first registered and while the individual remains registered with the server [[.]];

the server receiving second information transmitted by the individual through the one enduser computer terminal or another one of the plurality of end-user computer terminals, the second information including the personally-identifying information of the individual and information indicating the individual's request to withdraw the registration;

the server comparing the transmitted personally-identifying information with the stored personally-identifying information of the individual; and

the server withdrawing the individual's registration when the comparing step indicates a match between the transmitted personally-identifying information and the stored personally-identifying information.
