Continuation of 11. does NOT place the application in condition for allowance because:

Swanson teaches that a graphical resource editor uses a resource file to generate the information in the window 810 wherein the resource file contains the name and class of each listed application and the name and class of their corresponding app-custom file (col 9, lines 37-41) and if no app-custom file exists for the application, a default file is used (col 10, lines 13-14). Therefore, it is reasonable to interpret that Swanson teaches building the graphical display object first, based on the custom values for elements having such provided custom vaules, and then, on the default values for elements not having provided custom values.
