Drawings

Upon further consideration of the proposed substitute sheets of drawings, filed on May 30, 2000, they have been found to incorporate new matter. The substitute sheets therefore cannot be entered. The original disclosure does not support the showing of the numerous detailed orientations and relationships of the shown components in the new drawings. For example, a simple comparison of Figure 1 from both sets of drawings shows a marked difference, particularly in the details of element M101. 
