**DETAILED ACTION**

***Claim Rejections - 35 USC § 102***

The following is a quotation of the appropriate paragraphs of 35 U.S.C. 102 that form the basis for the rejections under this section made in this Office action:

A person shall be entitled to a patent unless –

(b) the invention was patented or described in a printed publication in this or a foreign country or in public use or on sale in this country, more than one year prior to the date of application for patent in the United States.

Claims 1-3 are rejected under 35 U.S.C. 102(b) as being anticipated by Apostolos et al (US 4,166,980).

Regarding claim 1, Apostolos teaches a method of identifying a signal type for an unknown signal (see abstract, see col. 2, lines 48-53) comprising the steps of: selecting the unknown signal of interest from a displayed spectral waveform for a specified range of frequencies (col. 1, lines 32-44); processing spectral data representing the unknown of interest to ascertain characteristics of the signal without demodulating the unknown signal (col. 6, lines 37-44) and from the characteristics of the unknown signal determining an identification of the signal type (col. 3, lines 56-59 and col. 13 lines 39-49).

Regarding claim 2, Apostolos teaches the determining step comprises the step of comparing the frequency of the unknown signal with a database of spectral assignments for a plurality of known signals to identify the signal type (col. 3, lines 43-51).

Regarding claim 3, Apostolos teaches a processing step comprises the step of estimating from the data an occupied bandwidth for the unknown signal as one of the characteristics for input to the determining step (col.5, lines 25-51).

***Allowable Subject Matter***

Regarding claims 4-6; please see reasons for allowance in office action # 2, dated 10/3/02.

Applicant's arguments with respect to claims 1-3 have been considered but are moot in view of the new ground(s) of rejection.
