DETAILED ACTION

Allowable Subject Matter

Claims 1-6 are allowed.

The following is an examiner's statement of reasons for allowance:

Regarding claim 1, the prior art of record, specifically Apostolos (4,166,980) discloses utilizing a particular modulation type so that once a signal bearing a particular type of modulation is identified, this signal can be singled out and shunted to a conventional receiver for more complete identification. In other words, Apostolos discloses processing spectral data representing the unknown of interest to ascertain characteristics of the signal without demodulating the unknown signal (col. 6, lines 37-44) and from the characteristics of the unknown signal determining an identification of the signal type (col. 3, lines 56-59 and col. 13 lines 39-49). However, the prior art of record neither alone or in combination fail to specifically disclose processing of spectral data to ascertain characteristics of the signal and more specifically Apostolos specifically states that "this is unlike spectrum analysis because the ordinate is not amplitude". Furthermore, Apostolos fails to specifically disclose selecting the unknown signal from a displayed spectral waveform for a specified range of frequencies.

It should be noted, that the present invention is very specific to the displayed spectral waveform environment and more specifically the selecting an unknown signal from a displayed spectral waveform for a specified range of frequencies. Although it is well known in the art to use displayed spectral waveform devices and also very well known in the art to select signals from the specific spectrum display, one would not find

motivation to combine any of the cited prior art with the fact that it is well known to use spectrum display devices.
