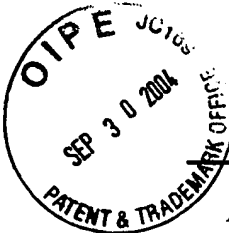

This paper is submitted in response to the Office Communication of September 9, 2004, to provide a Telephone Interview Summary.

Telephone Interview Summary

On August 25, 2004, a Telephone Interview was conducted with Examiner Cao and Mark S. Williams (Reg. No. 50,658). No exhibits were shown. Applicant proposed to amend the independent claims to include the limitation that the invocation of the graphical program via the functional interface is made *directly*, and submitted that this feature is not taught in the cited art. The Examiner indicated that this change would necessitate further search.
