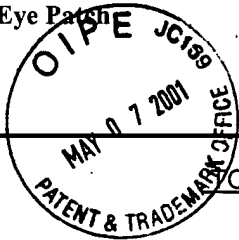

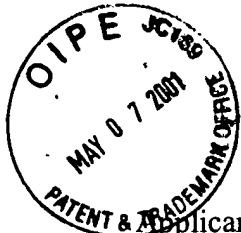

1. An eye patch usable with eyeglass frames that comprises a bridge and a side arm,  
2 the eye patch comprising:  
3 a flexible body to be positioned on a front of the frames to substantially block both frontal  
4 and peripheral vision of an eye;  
5 a first fastener to attach the body to the bridge; and  
6 a second fastener to attach the body to the side arm.

1 2. The eye patch of claim 1, wherein  
2 the eyeglass frames comprises a lens socket, and  
3 the body is adapted to at least partially extend over the lens socket.

1 3. The eye patch of claim 1, wherein  
2 the eyeglass frames holds a lens, and  
3 the body is adapted to at least partially extend over the lens.
