## **DETAILED ACTION**

### ***Allowable Subject Matter***

The following is an examiner's statement of reasons for allowance:

Oviatt teaches an eye patch to be positioned on eyeglass frames to extend across the lens receiving socket to block vision through a lens and extends substantially along the arm to block peripheral vision.

Heaford teaches an eye shield to cover the lens on eyeglasses.

Grindle teaches a visual field and lens occluder for eyeglasses. The field view of the eye of the wearer is occluded by the covered lens.

Mosher teaches an adjustable and removable eyeshade for eyeglasses.

None of Oviatt, Heaford, Grindle, or Mosher disclose or teach an eye patch usable with eyeglass frames having a flexible body to be positioned on the front of the frames to substantially block the frontal and peripheral vision of an eye, a first fastener attaching the body to the bridge, or second fastener to attach the body to the side arm.

Any comments considered necessary by applicant must be submitted no later than the payment of the issue fee and, to avoid processing delays, should preferably accompany the issue fee. Such submissions should be clearly labeled "Comments on Statement of Reasons for Allowance."
