

Continuation of 11. does NOT place the application in condition for allowance because: As previously stated by the examiner, Applicant's comments regarding McGuckin, Jr. are not understood in view of column 3 of the reference which discloses that diagnostic imaging guidance such as CT scans, fluoroscopic imaging, MRI etc can be used with the medical resecting device. Furthermore, applicant appears to argue the references individually and one cannot show nonobviousness by attacking references individually where the rejections are based on combinations of references. See *In re Keller*, 642 F.2d 413, 208 USPQ 871 (CCPA 1981); *In re Merck & Co.*, 800 F.2d 1091, 231 USPQ 375 (Fed. Cir. 1986)..
