### **EXAMINER'S AMENDMENT**

### ***Allowable Subject Matter***

2. Claims 22-28 are allowed.
3. The following is an examiner's statement of reasons for allowance:

The prior art of record does not teach or fairly suggest an OFDM-CDMA apparatus or method in which a frequency division multiplexer assigns known signal chips to subcarriers aligned in a frequency axis direction where the number of said subcarriers matches the spreading factor of the known signal. In light of the specification, the term "matching" in claims 22 and 24-28 is defined as "being the same in number as".
