

**REMARKS**

Claims 44-57 are new and claims 1-43 are canceled. As a result, claims 44-57 are pending in the present application

Applicants add new claims 44-57 to more particularly point out and clarify the present invention. New claims 44-57 contain no new matter and are supported by the entire specification, including drawings and the example support shown in the following table.


The Office Action rejected claims 1-43 under 35 U.S.C. § 102(b) as being anticipated by U.S. Patent No. 5,848,396 to Gerace (hereinafter "Gerace"). Applicants respectfully traverse this rejection because claims 1-43 are canceled.

Applicants request consideration of new claims 44-57. In general, Gerace does not anticipate these new claims which more particularly point out and clarify the present invention. New claims 44-57 are generally directed to systems and methods for automatic control of window viewing, web page viewing, and caching, as opposed to Gerace, which is directed to placing advertisement on a web page based on a user profile. (Gerace, abstract). New claims are directed to control of whole windows and whole web pages, while Gerace is directed to "agate" data within a web page. (Gerace, col. 1 lines 6-28). Therefore, Applicant requests consideration of new claims 44-57.

In view of the foregoing, Applicants respectfully submit that all of the claims in the present application are patentably distinguishable over the references cited in the Office Action. Accordingly, Applicants respectfully request reconsideration and that the claims be passed to allowance.
