### Notice of Non-Responsive Amendment

The amendment filed on 04/18/2005 canceling all claims drawn to the elected invention and presenting only claims drawn to a non-elected invention is non-responsive (MPEP § 821.03). The remaining claims are not readable on the elected invention because the applicants amended independent claims 1, 5 and 18 to recite at least the limitation, "an LCD panel driving circuit included in an information processing module", in lines 15-17 of claim 1, lines 16-18 of claim 5, and lines 14-16 of claim 18, which is not readable on the elected species II since fig. 10 shows an LCD panel driving circuit 537 separate from an information processing unit 540. Also see specification, page 17, line 25 through page 18, line 3. Furthermore, independent claims 1, 5 and 18 also recite the limitation, "a LCD monitor comprising an input unit arranged on a case of the LCD monitor", in last two lines of claims 1, 5, and 18, which is not readable on the elected species II since figs. 7 and 10 show an input unit (400, 401) separate from the LCD monitor 500.

Since the above-mentioned amendment appears to be a *bona fide* attempt to reply, applicant is given a TIME PERIOD of ONE (1) MONTH or THIRTY (30) DAYS, whichever is longer, from the mailing date of this notice within which to supply the omission or correction in order to avoid abandonment.
