MIGRATION AND ITS USE

DECISION

This is in response to applicant's "Petition for Withdrawal of Abandonment" filed 13 June 2005, which is being treated under 37 CFR 1.181. No petition fee is due.

BACKGROUND

On 05 March 1999, applicant filed international application PCT/US99/04996, which claimed priority of an earlier United States application filed 05 March 1998. A Demand for international preliminary examination, in which the United States was elected, was filed on 28 September 1999, prior to the expiration of nineteen months from the priority date. Accordingly, the thirty-month period for paying the basic national fee in the United States expired on 05 September 2000.

On 31 August 2000, applicant filed national stage papers in the United States Designated/Elected Office (DO/EO/US). The submission was accompanied by, *inter alia*, the basic national fee required by 35 U.S.C. 371(c)(1).

On 11 July 2001, the DO/EO/US mailed a Notification of Missing Requirements Under 35 U.S.C. 371 (Form PCT/DO/EO/905) and a Notification to Comply with Requirements for Patent Applications Containing Nucleotide Sequence and/or Amino Acid Sequence Disclosures (Form PCT/DO/EO/920).

On 13 November 2001, applicant filed a sequence listing in both paper and computer readable form.

On 25 August 2003, the DO/EO/US mailed a Notification of Abandonment (Form PCT/DO/EO/909), which indicated that the application is abandoned for failure to timely respond to the Notification of Missing Requirements.

On 13 July 2005, applicant filed the present petition under 37 CFR 1.181.

DISCUSSION

A review of the application file reveals that the sequence listing filed on 13 November 2001 is present.

CONCLUSION

For the reasons above, the petition under 37 CFR 1.181 is GRANTED.

The Notification of Abandonment (Form PCT/DO/EO/909) mailed 25 August 2003 is hereby <u>VACATED</u>.
