DETAILED ACTION

1. The amendment filed 7/8/04 has been entered.

Allowable Subject Matter

2. Claims 18-41 are allowed.
3. The following is an examiner's statement of reasons for allowance: Prior art fails to disclose a field emission apparatus comprising a field emission cathode comprising a polymer material forming an exposed field emission surface, as claimed. Prior art fails to disclose a field emission apparatus comprising a field emission cathode comprising a conjugate polymer material forming an exposed field emission surface, as claimed. Prior art fails to disclose a field emission display comprising a field emission cathode comprising a conjugated polymer material forming a field emission surface, as claimed. Prior art fails to disclose a method of fabricating a field emission cathode comprising the step of forming a polymer layer comprising conjugated polymer material on a substrate forming an exposed field emission surface of the field emission cathode, as claimed.
