

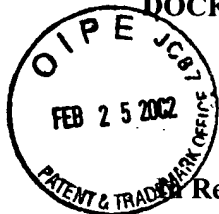

A Power of Attorney with Revocation and Statement Under 37 C.F.R. 3.73(b) was submitted on October 26, 2001, as evidenced by the documents submitted herewith. The envelope containing the attendant documents was sent by return mail back to Applicant's undersigned attorney, and was received in the attorney's office on January 22, 2002. Upon inspection of the envelope and its contents, it was readily apparent that the envelope had been irradiated, presumably to destroy Anthrax organisms. Irradiation of the envelope and contents caused the mailing label on the envelope to blacken, such that the addressee was no longer discernible. A copy of the envelope is submitted herewith. It is surmised that the mail was returned to the undersigned attorney, whose address was still visible, because the U.S. Postal Service was unable to determine the original addressee.
