

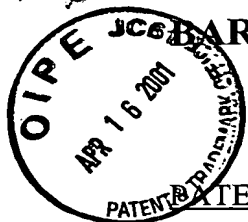


1. The executed Declaration for the above-identified application;
