Examiner's Amendment

Reasons For Allowance

The following is an examiner's statement of reasons for allowance: with respect to claim 14 the recitation of the leg holder as recited in the final paragraph of the claim is an overlooked aspect not shown or suggested by Klevstad (US 4,426,071). Klevstad does not show or suggest a leg cradle mounted between an operator device and a clamping device which is also movable around a first plurality of axes in the fashion claimed. With respect to claim 24, the recitation of the coupler configured to couple a leg holder to an elongated member is an overlooked aspect that is not shown or suggested by the Klevstad patent. In claim 48 the recitation of a leg holder coupled to a tube a first distance away from the clamping device is an overlooked aspect that is not shown or suggested by the Klevstad patent. Finally, with respect to claim 49 the recitation of a leg holder lockable relative to a support device and releasable to move relative to the support

device about a second plurality of axes is an overlooked aspect that defines over what is shown in Klevstad.
