

EXAMINER'S AMENDMENT

REASONS FOR ALLOWANCE

4. Claims 1 – 11, 13 – 32, 34 – 36, 38 - 42, 54 - 58 are allowed.

5. The following is an examiner's statement of reasons for allowance:

6. French teaches persistent network connections that can survive logoff and persist across logon. It discloses a method that requires persistent connections software resident on the client device (see French's column 2, lines 34-36), and requires that data structures in support of the persistent connection be stored at the client device (see French's column 6, lines 40-45). However, French does not teach the method implemented in a server, and determining whether a recovery of the file server after the offlining is to be accomplished by rebooting the server or takeover by another server, when taken in the context of claims as a whole, is not uncovered by French and Kemp. Moreover, evidence for the modifying the prior art teachings by one of ordinary skill level in the art was not uncovered so as to result in the invention as recited in claims 1, 22, and 55.


