DETAILED ACTION

1. Claims 34, 36 and 37 are allowed. Claims 34, 36 and 37 are re-numbered as claims 1-3.

Allowable Subject Matter

2. The following is an examiner's statement of reasons for allowance: The closest prior art of record discloses a method of encrypting digital content using content key generated from cipher key information and copy control information received from a data provider/set-top box. The closest prior art of record does not explicitly disclose the copy control information and the cipher key information is acquired from different sources. Specifically, the prior art does not explicitly disclose wherein the cipher key information is scrambled and prestored on the information recording medium and non-scrambled data including copy control information that is not scrambled, from content data which is acquired from an entity other than the information recording medium in light of other features disclosed in independent claims 34, 36 and 37.


