DETAILED ACTION

A request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e), was filed in this application after final rejection. Since this application is eligible for continued examination under 37 CFR 1.114, and the fee set forth in 37 CFR 1.17(e) has been timely paid, the finality of the previous Office action has been withdrawn pursuant to 37 CFR 1.114. Applicant's submission filed on 1 November 2004 has been entered.

This Office action is in response to (i) applicants' amendment (to the specification) filed 7 September 2004 which add the sequence identifiers to the peptide sequences: Leu-Leu-Arg-Gly-Tyr-Lys-Gly-Gly-His-(page 4, [0013]), -Asn-Gly-Glu and Ala-Ala-Glu-(page 5, [0017]), NH₂-Ala-Ala-Ala-Ala-Gly-Ser-(page 5, [0022]), and, Ser-Leu-Asp-Lys-Arg-(page 7, [0031]); and (ii) applicants' amendment filed 2 July 2004, which cancels claims 2, 5-7, 20-21, 23-45, 48-50 and 54, and amends claims 1, 3-4, 9, 11-12, 14, 47 and 52. The amendment indicated above has been entered. Also, the applicants' request (filed 1 November 2004) for extension of time of three months has been entered. It is of note that amendment (filed 7 September 2004) to claim 1, change "Ans" to "Asn" has been entered because the said amendment is supported bt the specification (see page 6, line 12), and thus does not constitute new matter. The pending claims 1, 3-4, 8-19, 22, 46-47, 51-53 and 55 are therefore examined in this Office action.

EXAMINER'S AMENDMENT

An Examiner's Amendment to the record appears below. Should the change and/or additions be unacceptable to Applicant, an amendment may be filed as provided by 37 C.F.R. § 1.312. To ensure consideration of such an amendment, it MUST be submitted no latter than payment of the Issue Fee.

Authorization for this Examiner's Amendment was given in a telephone interview with Rochelle K. Seide on November 17, 2004. Applicants agree the Examiner proposed amendment to claims 1, 3, 8, 10-11, 14, 51-52 and 55 (see below).

Amendments to the claim:

The pending claims 1, 3, 8, 10-11, 14, 51-52 and 55 have been amended or canceled as follows. Please replace the previous claims with the claim shown below.

Claim 1 (*Twice amended*): After, "1 to 10 amino acid residues," change "at least one of which ..." to "wherein at least one of said residues ...".

Claim 3 (Amended): Change "4 basic amino acids" to "4 amino acid residues".

Claim 8 (*Amended*): Change "1 amino acid, and X_{ac} " represents 1 acidic amino acid" to "one amino acid residue, and X_{ac} " represents one acidic amino acid residue".

Claim 10 (Amended): After "-Asn-Gly-Glu-" add "(SEQ ID NO: 50)".

Claim 11 (Amended): Under "Xaa", change "one acidic amino acid" to "one acidic amino acid residue"; and under "Xag ...", change "1 amino acid residue" to "one amino acid residue".

Claim 14 (Amended): After "either of its ends" add "(N-terminus and C-terminus)".

Claim 51 (Amended): Change "one acidic amino acid" to "one acidic amino acid residue".

Claim 52 (Amended): After "Xaa'-Gly-Xaa"- ", delete "(SEQ ID NO:42)". Claim 55 (Amended): After "-Glu-Xag' ", delete "(SEQ ID NO:45)".

Amendments to the specification:

Figure 1: A DNA unit resulting from the hybridization of the oligonucleotides which is flanked by the HindIII and BglII restriction sites for constructing pSEA1 plasmid.

Figure 2: The schematic structure of the plasmid pRTL-2 GUS.

Figure 3: A schematic structure of an expression cassette for synthesizing a PR-1 α -heliomicine fusion protein.

Figure 4: A fragment of the plasmid pRPA-RD 195 which shows a modified cloning site of an expression vector comprising the cassettes for expression of an Agrobacterium tumefaciens.

Figure 5: The schematic structure of pRPA-RD-174, wherein "nos" represents the Agrobacterium tumefaciens nopaline synthase polyadenylation site: "NOS pro" represents the Agrobacterium tumefaciens nopaline synthase promoter; "NPTII" represents the E. coli Tn5 transposon neomycin phosphotransferase gene, "35S pro" represents the 35 S promoter isolated from the cauliflower mosaic virus; "BRX" represents the nitralase gene isolated from K. ozaenae; and, "LB" represents the right and left borders respectively of the sequence of an Agrobacterium tumefaciens Ti plasmid.

Figure 6: The schematic structure of the plasmid pRPA-RD-184 wherein the terms "nos", "NPT-II", "NOS pro", 35 S pro", "BRX gene", RBX" and "LB" have the same meaning as in Figure 5.

Conclusion: Claims 1, 3-4, 8-19, 22, 46-47, 51-53 and 55 are allowable over the art of record.
