EXAMINER'S AMENDMENT

Election/Restrictions

1. This application is in condition for allowance except for the presence of claims 46-65 directed to an invention non-elected without traverse. Accordingly, claims 46-65 have been cancelled. Examiner notes the typographical error in the response to the restriction and therefore interprets the elected claims of group III as 66-90.

Allowable Subject Matter

1. Claims 66-90 are allowed.
2. The following is an examiner's statement of reasons for allowance: The prior art fails to render obvious defining parameters including a border and modifying the parameter without applying the border to the image itself .
