


The following is an examiner's statement of reasons for allowance: In addition to the reasons set forth in the Final Rejection mailed on June 4, 2003, the prior art does not teach to provide a magnetic shield surrounding surfaces of the magnet on a moving yoke in a linear motor that do not face an electromagnetic coil, or to provide a first magnetic field shield between a stage driver, which has a magnet and an electromagnetic coil, and a sample on the stage moved by the driver and a second magnetic field shield between the first shield and the sample.
