DETAILED ACTION

Continued Examination Under 37 CFR 1.114

A request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e), was filed in this application after final rejection. Since this application is eligible for continued examination under 37 CFR 1.114, and the fee set forth in 37 CFR 1.17(e) has been timely paid, the finality of the previous Office action has been withdrawn pursuant to 37 CFR 1.114. Applicant's submission filed on October 8, 2003 has been entered.

Allowable Subject Matter

Claims 1-6 are allowed.

The following is an examiner's statement of reasons for allowance: As the claims were read and interpreted in light of the specification, the prior art of record fails to specifically disclose an optical waveguide module in which a transmitted light emitted from a laser light-emitting element passes through a first optical waveguide to strike a transmitting/receiving medium, in which a signal light from the transmitting/receiving medium passes through the second optical waveguide and is received by a light receiving element, where a first light-blocking resin covers over the light-emitting element and first optical waveguide and a second light-blocking resin covers the part over the monitoring light receiving element and second optical waveguide, and in particular, where the first and second optical waveguides are integrated optical

waveguides disposed on a waveguide substrate with the light emitting-element and light-receiving element disposed on opposite sides of the waveguide substrate.
