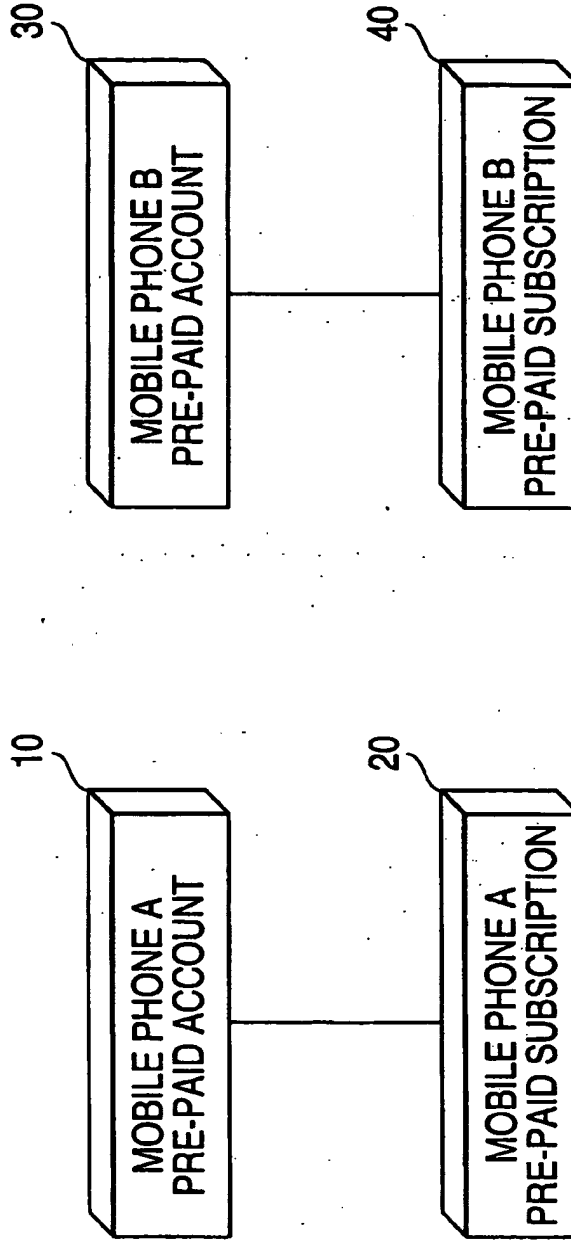

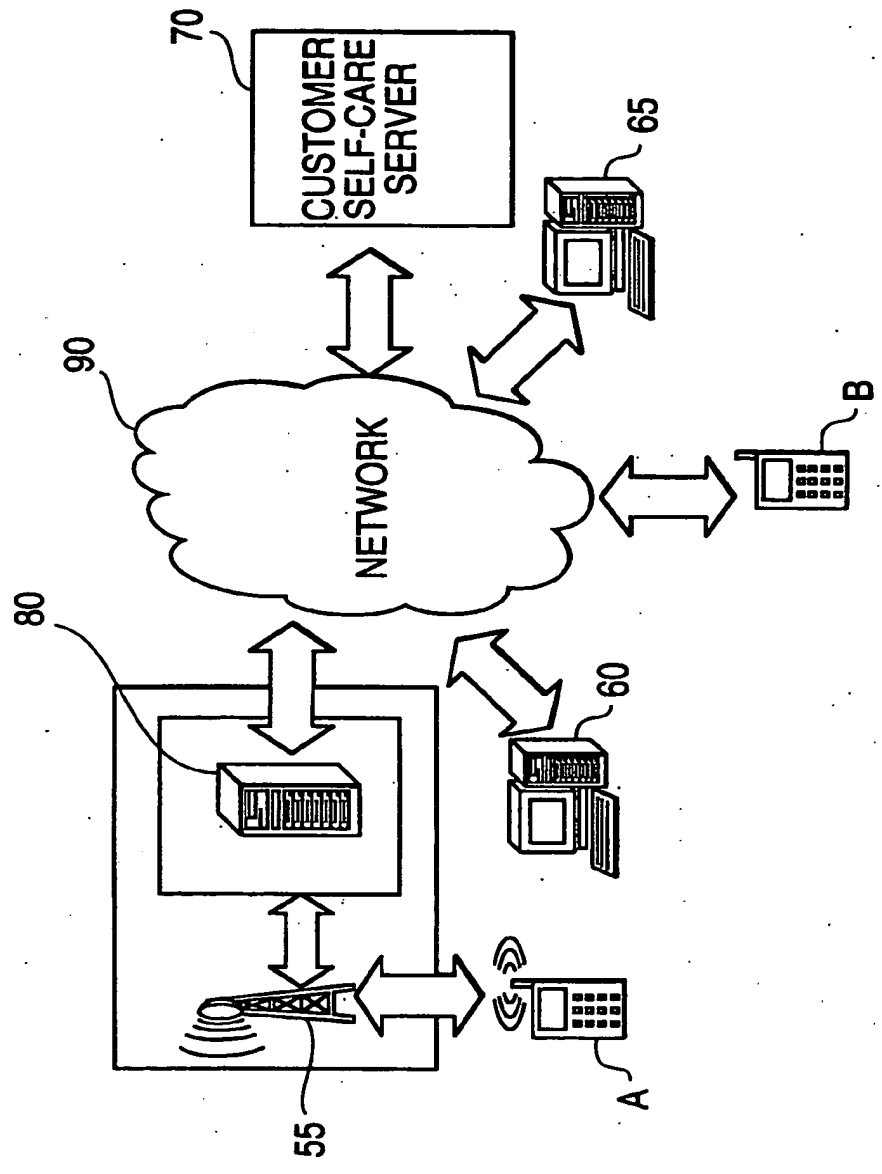
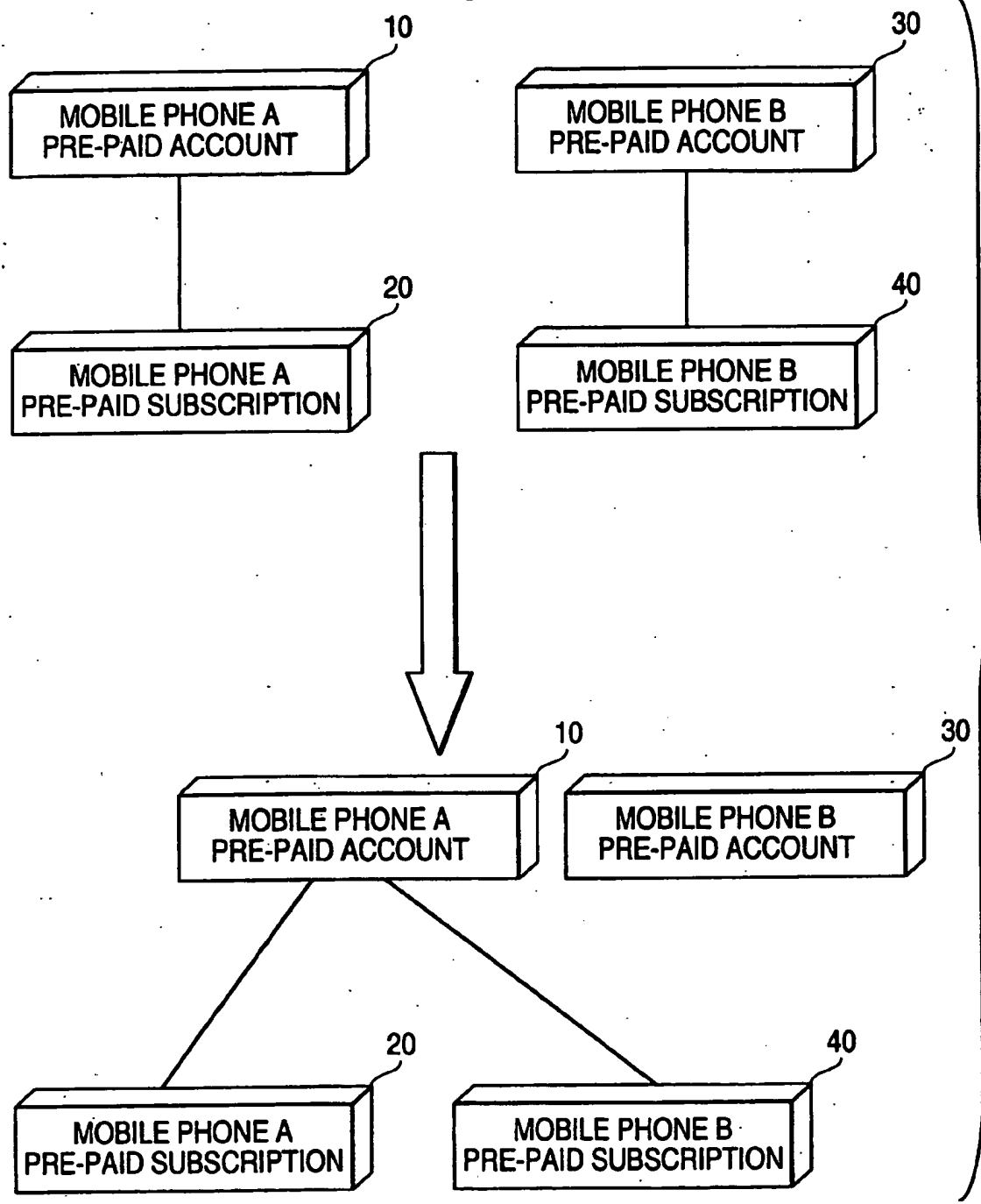

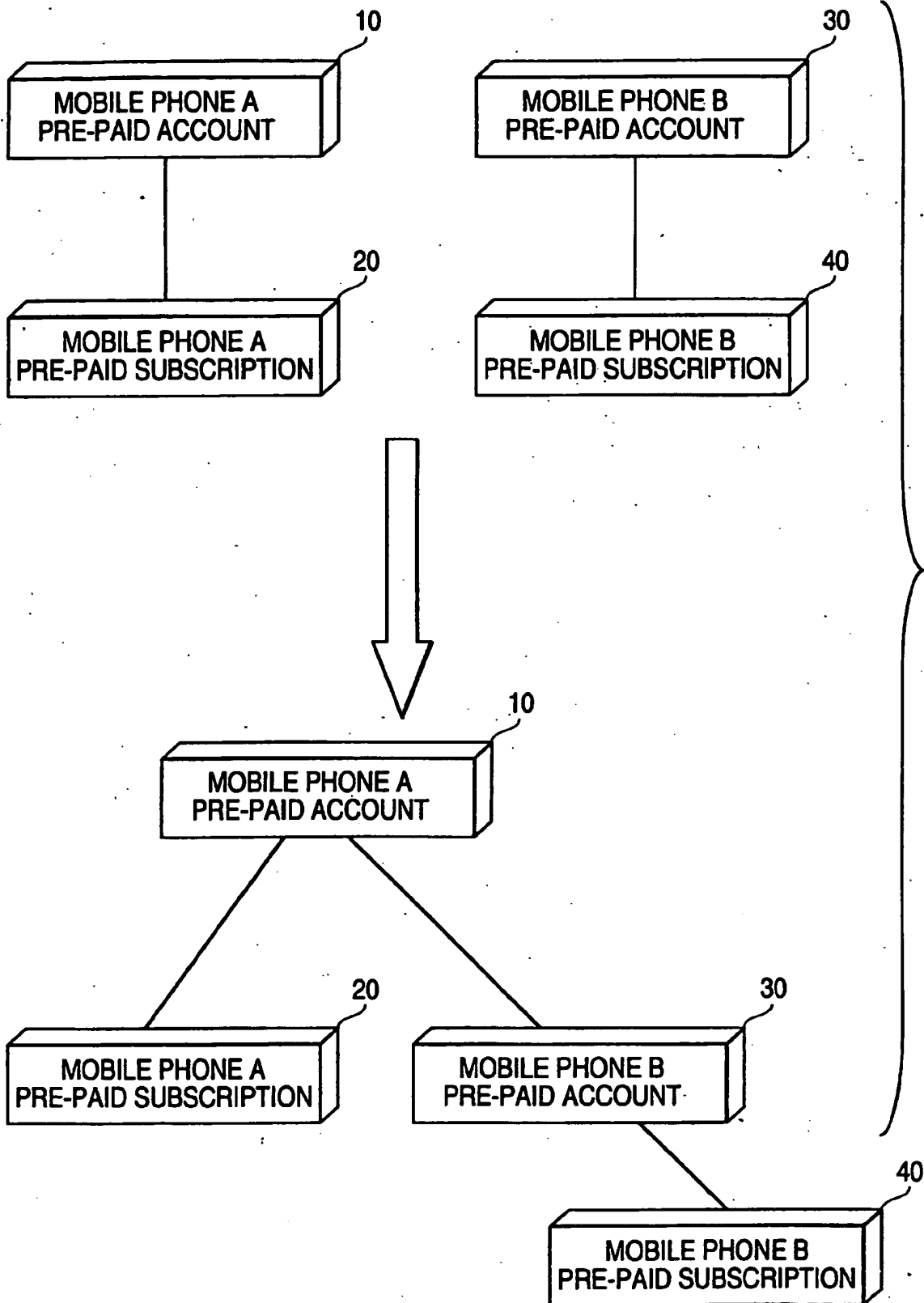
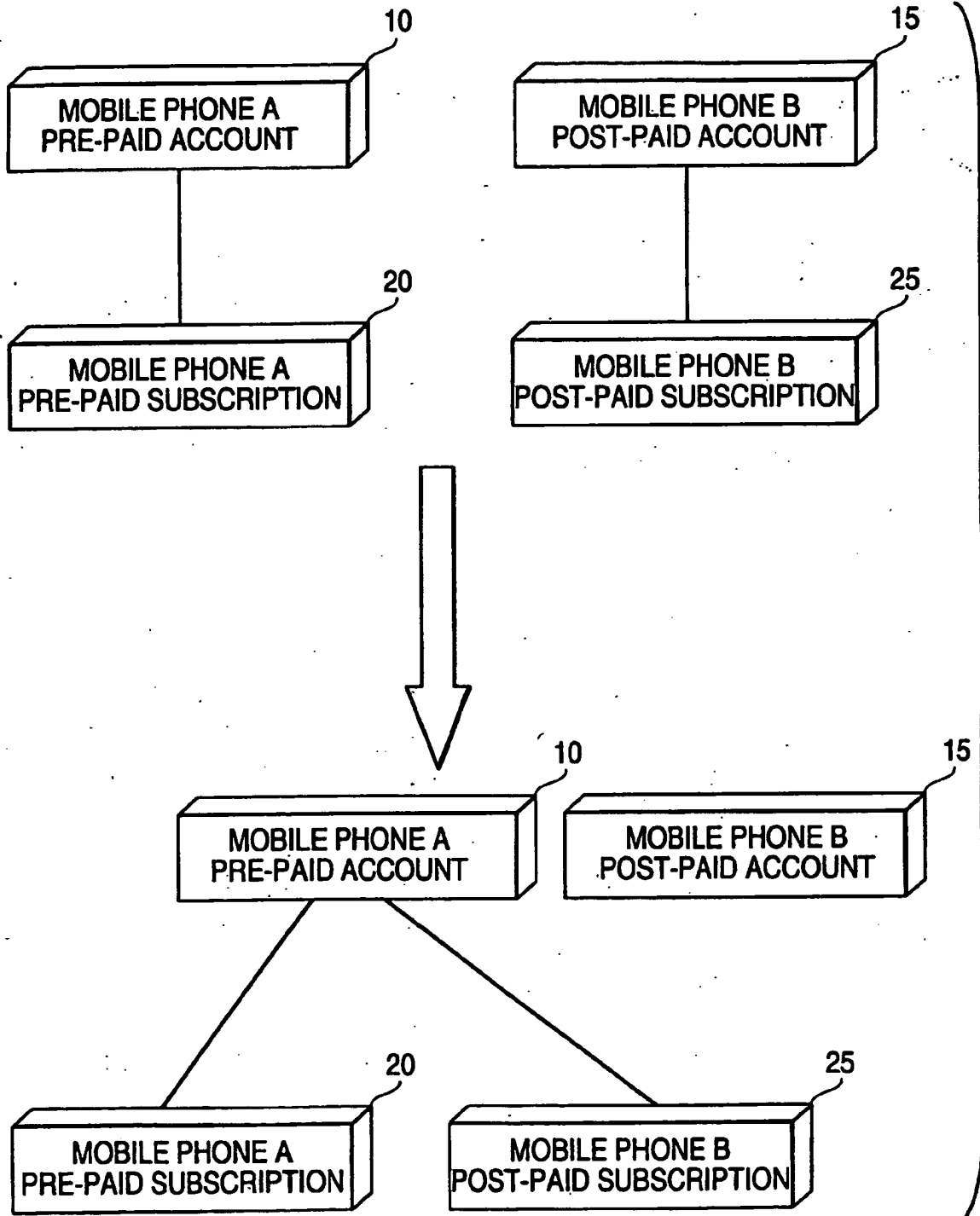

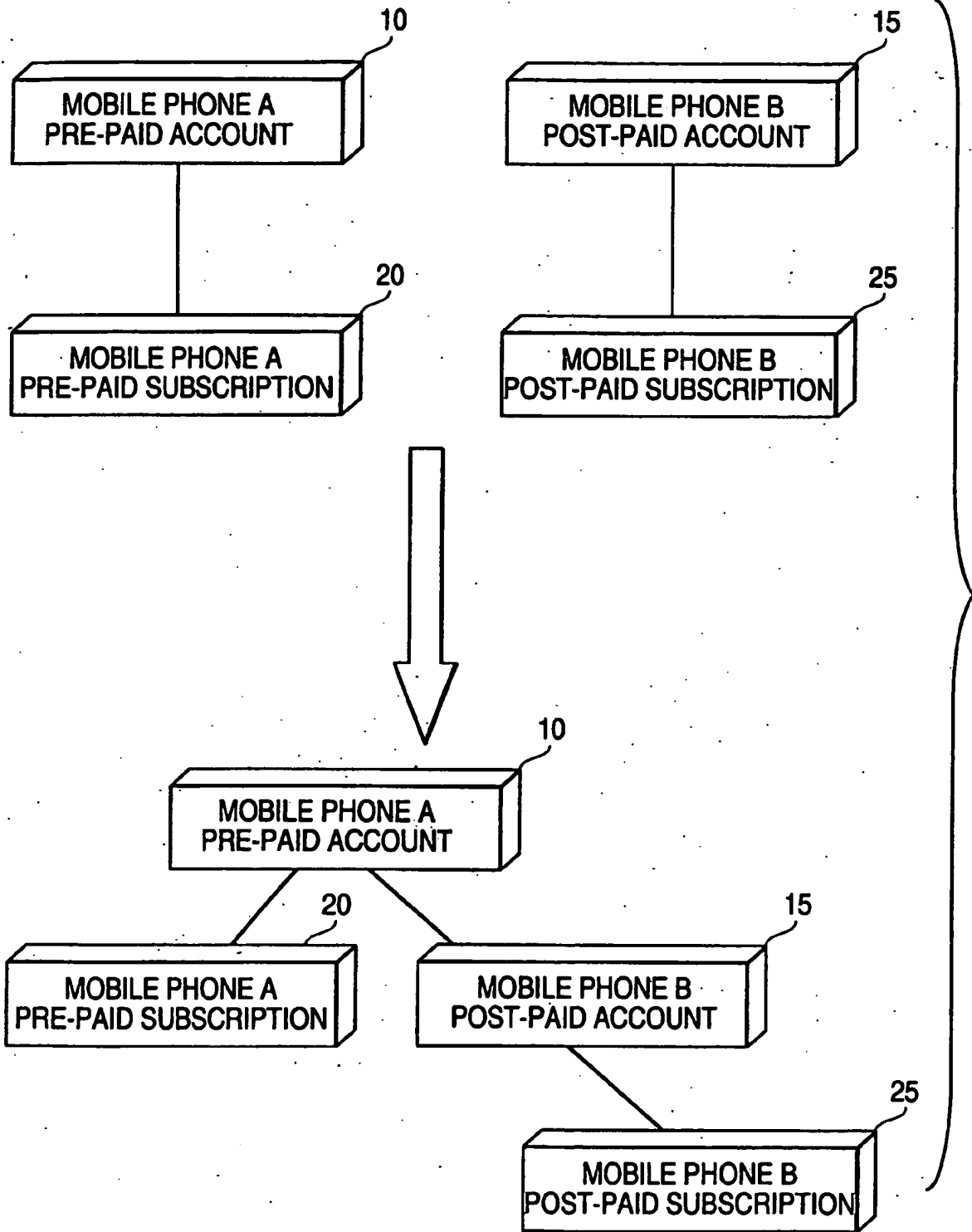

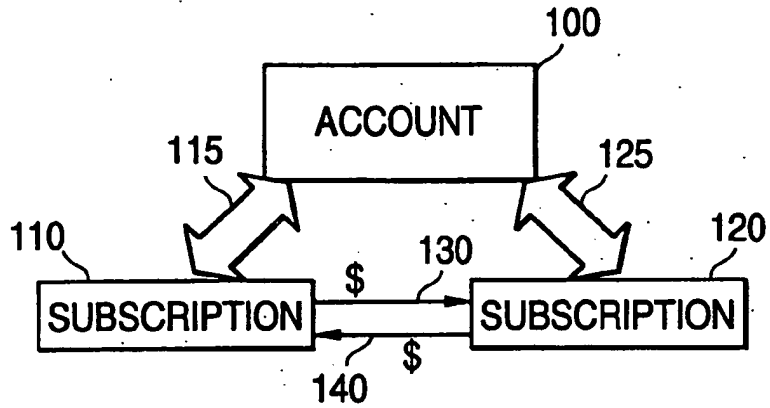

INITIAL RELOAD VALVE = \$100

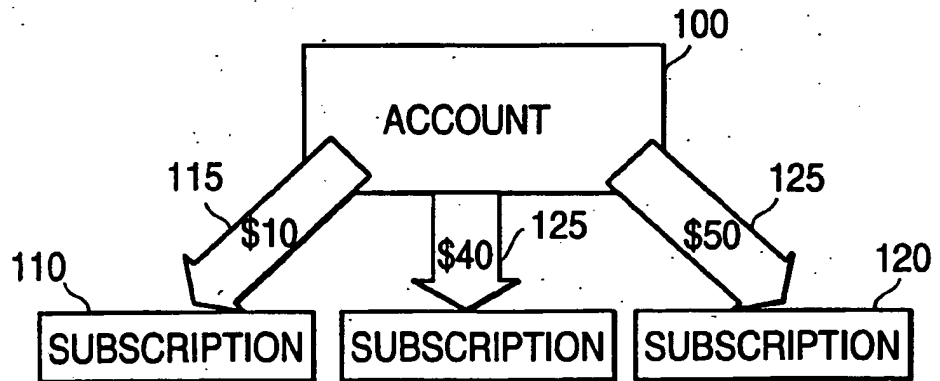
