## Summary of Record of Interview Requirements

### Manual of Patent Examining Procedure (MPEP), Section 713.04, Substance of Interview Must be Made of Record

A complete written statement as to the substance of any face-to-face, video conference, or telephone interview with regard to an application must be made of record in the application whether or not an agreement with the examiner was reached at the interview.

### Title 37 Code of Federal Regulations (CFR) § 1.133 Interviews

#### Paragraph (b)

In every instance where reconsideration is requested in view of an interview with an examiner, a complete written statement of the reasons presented at the interview as warranting favorable action must be filed by the applicant. An interview does not remove the necessity for reply to Office action as specified in §§ 1.111, 1.135. (35 U.S.C. 132)

#### 37 CFR §1.2 Business to be transacted in writing.

All business with the Patent or Trademark Office should be transacted in writing. The personal attendance of applicants or their attorneys or agents at the Patent and Trademark Office is unnecessary. - The signature of the examiner who conducted the interview (if Form is not an attachment to a signed Office action)

It is desirable that the examiner orally remind the applicant of his or her obligation to record the substance of the interview of each case. It should be noted, however, that the Interview Summary Form will not normally be considered a complete and proper recordation of the interview unless it includes, or is supplemented by the applicant or the examiner to include, all of the applicable items required below concerning the substance of the interview.

### Examiner to Check for Accuracy

If the claims are allowable for other reasons of record, the examiner should send a letter setting forth the examiner's version of the statement attributed to him or her. If the record is complete and accurate, the examiner should place the indication, "Interview Record OK" on the paper recording the substance of the interview along with the date and the examiner's initials.

Continuation of Substance of Interview including description of the general nature of what was agreed to if an agreement was reached, or any other comments: Applicant's representative asked the examiner to suggest allowable subject matter. The examiner indicated that claims directed to compositions comprising specific reagents at specific concentrations may be allowable with a showing of unexpected or improved qualities regarding such specific compositions. The examiner indicated that the claims as written were very broad and encompassed compositions taught in the art. Applicant's representative asserted that none of the references cited recite a composition wherein a thermostable enzyme retains at least 90% of its enzymatic activity for at least 4 weeks when said composition is stored at about 20 to 25 deg. C. The examiner indicated that such recitation refers to a property of the composition, which does not have to be explicitly stated in a reference. The examiner indicated that the previous office actions addressed the claimed properties with regard to the references. The examiner indicated that if applicants had evidence to show that the compositions set forth in the cited reference of Scalice was not stable as required by the claim, such evidence could be submitted and would be considered.

Continuation of Substance of Interview including description of the general nature of what was agreed to if an agreement was reached, or any other comments: Applicant's representative disagreed with the examiner's assessment of the claims as now amended, and the election of species. Applicant's representative indicated that he would further discuss the election of species with applicant and that they would respond to the election of species in writing. The examiner indicated that should the generic claims become allowable, that the election of species would be withdrawn and that all pending claims would be allowed. The examiner and applicant's representative agreed to discuss ways of amending the claims to overcome the prior art after the examiner conducted her search.
