DECLARATION OF MARINA F. CUNNINGHAM IN SUPPORT OF
PETITION TO OBTAIN EARLIER DATE OF RECEIPT OF 35 U.S.C. § 371(c)(1), (c)(2)
AND (c)(4) REQUIREMENTS, AND DATE OF RECEIPT OF ALL 35 U.S.C.
REQUIREMENTS

S I R:

This is a Declaration in support of the Petition to Obtain Earlier Date of Receipt of 35 U.S.C. § 371(c)(1), (c)(2) and (c)(4) Requirements, and Date of Receipt of All 35 U.S.C. Requirements. The sequence of events is as follows:

1. My name is Marina F. Cunningham. I am a partner at McCormick, Paulding & Huber LLP, and am the attorney of record in the above-identified matter.
2. The above-identified application was filed on January 11, 2001 via Express Mail.

3. After a number of attempts to determine status of the application via telephone, we filed a Status Request on February 28, 2002. In response to our Status Request, we received a Notice of Abandonment (Exhibit A).
4. Our firm filed on May 15, 2002 a Petition to Withdraw Holding of Abandonment Based on Failure to Receive the Notification of Missing Requirements (First Petition), along with an Accompanying Declaration in support of the Petition (First Declaration) in the above-identified patent application. A copy of the First Petition and accompanying First Declaration is attached as Exhibit B to this present Petition.
5. A number of calls were made to the USPTO prior to July 9, 2002. Mr. Derek Woods of the USPTO informed me on July 9, 2002, that the Petition to Withdraw Holding of Abandonment was not received. A copy of the Petition was faxed to the USPTO (Exhibit C).
6. A Status Request was filed on July 9, 2002 stating that Applicant has not received a response to the First Petition, and inquiring as to the status of the application. A copy of the Status Request of July 9, 2002 and a copy of the stamped accompanying postcard receipt dated July 15, 2002 is attached as Exhibit D to this present Petition.
7. Numerous phone calls were placed to the USPTO by me and various conversations with Mr. Daniel Stemmer and Ms. Erin Pender took place in an attempt to determine status of the application and expedite petition process.
8. A further Status Request was filed on November 6, 2002 stating that this was Applicant's third request for a status update throughout the application process. A copy of the Status Request of November 6, 2002 and a copy of the stamped accompanying postcard receipt dated November 14, 2002 is attached as Exhibit E to this present Petition.
9. My Legal Assistant, Elizabeth Dudek, phoned the PCT Help Desk on January 14, 2003 and spoke with Paul Bell, PCT Special Programs Examiner, in order to determine to whom the next status request should be addressed since our firm had not yet received a response to our previous status requests. Mr. Bell informed Ms. Dudek that our Petition to Withdraw Holding of Abandonment had been granted on September 24, 2002 and that the application was passed to the Examiner in charge of the case. Ms. Dudek informed Mr. Bell that a copy of the grant notice had not been received by our firm. Mr. Bell indicated that he could not provide us with a copy of

the grant notice since the application was with the Examiner. Mr. Bell further indicated that the Examiner (not identified) should be forwarding the Notice of Acceptance within the next week.

A copy of an Internal Memorandum addressing this additional attempt to determine the status of the present application is attached as Exhibit F to this present Petition.

10. I had a further telephone conversation with Mr. Bell on January 24, 2003 and it was agreed to fax him a copy of the executed inventor Declaration, Power of Attorney and Appointment of Domestic Representative for filing in connection with the present application. On the same day (January 24, 2003) as our telephone conversation, I faxed Mr. Bell the executed inventor Declaration. A copy of the faxed transmission including the executed inventor Declaration is attached as Exhibit G to this present Petition.

11. On January 27, 2003 I received from Mr. Bell a faxed memo including: 1) a copy of the Notice of Missing Requirements; 2) a Letter of April 17, 2002 from Paralegal Specialist Jeremy Fleming regarding the status of the present application; 3) the Notification of Abandonment dated April 26, 2002; and 4) a Decision Letter dated September 24, 2002 from Attorney Advisor Erin Pender granting Applicant's May 28, 2002 Petition to Withdraw Holding of Abandonment. The Decision Letter indicates that a review of the file reveals that both the copy of the Notification of Missing Requirements and the original are in the file at the PTO. In other words, the PTO admits that the Notification of Missing Requirements was never mailed. A copy of the faxed memo is attached as Exhibit H to this present Petition.



I received a faxed transmission dated January 27, 2003 from Tammy Holland for Francine Young of PCT Operations at the PTO including: 1) a Withdrawal of Previously Sent Notice dated January 27, 2003 stating that the Notice of Abandonment mailed on April 26, 2002 (which was not received until January 27, 2003) was sent in error and is hereby withdrawn; 2) a Filing Receipt stating that the filing date of the present application is January 24, 2003; and 3) a Notice of Acceptance of Application Under 35 U.S.C. 371 AND CFR 1.494 OR 1.495 (Notice of Acceptance) mailed on January 27, 2003. The Notice of Acceptance states that the Date of Receipt of 35 U.S.C. § 371(c)(1), (c)(2) and (c)(4) Requirements is January 24, 2003, and that the Date of Receipt of All 35 U.S.C. Requirements is January 24, 2003. The Date of Receipt of 35 U.S.C. § 371(c)(1), (c)(2) and (c)(4) Requirements is the date

which a patent issuing from the present application can be used as 35 U.S.C. § 102(e) prior art. A copy of the faxed transmission dated January 27, 2003 is attached as Exhibit I to this present Petition.

13. In view of Applicant's diligence in moving the prosecution of the present application along in response to the above-discussed errors and delays of the PTO, Applicant respectfully requests that an earlier Date of Receipt of 35 U.S.C. § 371(c)(1), (c)(2) and (c)(4) Requirements, and Date of Receipt of All 35 U.S.C. Requirements be secured in accordance with the situation where Applicant would have timely received and thereby promptly responded to the Notification of Missing Requirements.

14. No fee is believed to be due for filing this Petition. However, if it is determined that a fee is required, please charge our Deposit Account No. 13-0235.


