

***Response to Amendment***

1. Applicant's amendment was received on 9/12/05, and has been entered and made of record. Currently, **claims 2-7** are pending.

***Allowable Subject Matter***

2. **Claims 2-7** are allowed. These claims will be renumbered as 1-6.

3. The following is an examiner's statement of reasons for allowance:

Independent claims 4 and 7 define a system for discriminating between a case in which an operator intentionally transmits a subaddress including symbols (or particular information), and another case in which the operator transmits a subaddress signal including the symbols in compliance with the ITU-T Recommendation T.33,

wherein a confirmation message, confirming whether to send the symbols as information in accordance with ITU-T Recommendation T.33, is displayed in the display means,

wherein the symbols are directly inputted by direct input means.

The most relevant prior art Endo (U.S. Patent No. 6,449,062) teaches a data transmission method wherein a message that is communicated from a first communication machine to a second communication machine is stored in a memory area in the second communication machine. However, Endo does not teach "displaying means for displaying an acknowledge message which is to confirm whether to send the particular information as information in accordance with ITU-T Recommendation T.33 when the particular information is input from the direct input means".
