## In the Claims

Please amend the claims as follows. The claims are amended in accordance with 37 C.F.R. §1.121. No new matter has been added.

1. (Amended) A contactless data carrier, comprising:

an electronic circuit module including an antenna coil and an integrated circuit electrically connected to each other; and

a hollow resin case provided with a first slit,

wherein the electronic circuit mødule is contained in the hollow resin case, and the first slit spatially connects an inside and an outside of the hollow resin case.
