


In response to the Office action of 07/31/2002, applicant submits the following:

REMARKS/ARGUMENTS

Claims 1-21 are pending in the present application. The Examiner has rejected claims 1-5, 7-15, and 17-21. The Examiner has objected to claims 6 and 16. Applicant respectfully requests reconsideration of pending claims 1-21.

The Examiner has objected to claims 6 and 16 as containing subject matter which was allegedly not described in the specification in such a way as to reasonably convey to one skilled in the relevant art that the inventor(s), at the time the application was filed, had possession of the claimed invention. The Examiner further alleges that "[t]he applicant did not disclose the capability of transmitting two bits of information over a single conductor."

Applicant respectfully disagrees. As one example, Applicant cites page 10, lines 27-31, which state, "Receiver 116 may provide desirable characteristics, for example, one or more voltage or current level thresholds Receiver 116 may be able to receive one or more bits of information over a single conductor simultaneously." As another example, Applicant also cites Figs. 9, 10, 12, and 13, and the descriptions corresponding thereto, which illustrate quad Rambus signaling level (QRSL) circuits____ capable of representing-two bits of information simultaneously over a single conductor.
